NARRATIVE SUMMARY			
Protection is mixed in municipal worksites, private worksites, and restaurants, with designated smoking areas allowed if separately ventilated. However, coverage is partial due to exceptions, ambiguities, or legal issues. No protection is provided in bars in restaurants, and bars not in restaurants. Fines up to \$2,000 exist for violations by businesses and smokers. The director of the department designated by the city administrator to enforce and administer this article is the enforcer.
