\*100% Smoke Free (5) - No smoking allowed in a particular setting; Moderate (4) - Designated smoking areas are allowed if separately ventilated; Mixed (3) - Coverage is partial due to exceptions, ambiguities, or legal issues; Limited (2) - Designated smoking areas allowed or required; No Coverage (1) - No restrictions on smoking. Minor exceptions may exist.

### DEFINITION OF SMOKING

Smoking defined as: Cigar, cigarette, electronic or digital smoking device, pipe, a lighted or unlit plant product (including tobacco), or inhaling or exhaling from an electronic vaping device

### NARRATIVE SUMMARY

Smoking is prohibited (100% smoke free) in municipal worksites, private worksites, restaurants, and bars not in restaurants. No protection is provided in bars in restaurants. Fines up to \$2,000 and other penalties exist for violations by businesses and smokers. No enforcer is named.
