## 2016 Summary of SHS Ordinance Activity

- 11 smoking ordinances passed in 10 cities (through June)
- All 11 ordinances in 10 cities included e-cigarettes
- 8 cities passed smoking ordinances addressing 5 focal areas
  - Haltom City (13 June 2016) refers to parks
  - Nederland (13 June 2016) refers to recreation center
- 1 city passed two ordinances
  - Port Arthur 100% smoke-free ordinance (5 Apr 2016); removed restrictions for Private Worksites and Bars (31 May 2016)

## 2015 Summary of SHS Ordinance Activity

- 10 smoking ordinances passed in 9 cities
- All 10 ordinances in 9 cities included e-cigarettes
- 8 cities passed smoking ordinances addressing 5 focal areas
  - Wichita Falls extended previous 2014 100% smoke-free ordinance (17 June 2014) to outdoor restaurant seating (4 Aug 2015)
- 1 city passed two ordinances
  - Port Lavaca 100% smoke-free ordinance (13 Apr 2015); created exception for vape shops (8 June 2015)

- 16 smoking ordinances passed in 16 cities
- 9 ordinances in 9 cities included e-cigarettes
- 15 cities passed smoking ordinances addressing 5 focal areas
  - Eastland (21 July 2014) relates to sale of e-cigarettes to minors




#### Percentage of the Texas Municipal Population Protected by 100% Smoke-Free Ordinances in all Five Settings\*


### Percentage of the Texas Municipal Population Protected by 100% Smoke-Free Ordinances in Three or More Settings\*
